- f. FREE AMBULANCE services for emergency cases within 5 km radius (Subject ot availability)
- 2. Hospital will issue privilege card to all members of the Institute along with dependents to avail the above privileges.
- 3 Members of the Institute can avail the above privileges at SAGAR HOSPITALS -1AYANAGAR & SAGAR HOSPITALS - KUMARASWAMY LAYOUT.
- 4. Institute has agreed to provide its members list along with the mobile numbers to hospital to issue Sagar Privilege card.
